Dangerous materials or substances such as poisons, acids, caustics, infected materials and explosives. Materials which have not been prepared in accordance with the above. Solid wastes resulting from industrial processes. Bulky Items such as refrigerators, stoves washers, dryers, tires, automotive items, beds, springs, mattresses, furniture or other items of bulk and similar
