SP-02-2016-Stewarts-3259 State Route 28-Tax Map# 83.-2-58

Steven Kinley and Chris Potter from Stewart's were present to explain the plan for a new store. They are under contract to buy 3 to 4 parcels to build a new store which will be about 3675 sq feet, with a 20x92 canopy for 3 gas pumps 1 diesel pump and 1 kero pump. The new plan will also include 27 parking spaces. They have filed a JIF with the APA and will need to do a SWIP

with DEC. Mrs. Deppe asked when a possible opening would be and Mr. Kinley said that it is possible if everything goes well they could be done by the end of the year.
