Current language : Full-time employees in Town Service shall be entitled to the following ten (11) legal holidays, which will be paid holiday of they are observed on a scheduled workday: New Year's Day, Martin Luther King Jr. Day, The Third Monday in February for observance of Lincoln's and Washington's birthdays, Memorial Day, Juneteenth, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day and Christmas Day. Since benefits regarding holidays vary with your employment situation (full-time, part-time, temporary, highway, elected, etc.) please ask your department head for clarification.

5. The following projects for 2022 were submitted by Highway Superintendent Comstock for agreement of the board: (commonly labeled 284 Agreements)

Pave 1.3 miles on Harrington Rd., 2900' on Cemetery Rd. in North River, 500' on Durkin Rd that was approved for 2021 Pave The Lane in Wevertown,

Also, replace a culvert on Beach Rd. that will be a 5' x 30' Galvanized squash pipe, another 5' x 30' Galvanized squash pipe for Vacar Rd.

We will not need any roads to be reclaimed this year, which will save the town a substantial amount of money.

6. Set mileage compensation for town business for 2022 to match IRS rate of 58.5 cents per mile.

7. Schedule the 2023 Organizational Meeting Tuesday, Jan 3, 2023 at Tannery Pond Community Center and virtually at 7:00 pm.
