With a motion by Mr. Vanselow and seconded by Mr. Bergman a Public Hearing was scheduled for February 26, 2007 at 7:00 PM.

## PEACEFUL VALLEY TOWNHOUSED

Peaceful Valley Townhouse Project is removing the median to comply with New York State Law of road widths within subdivision.

Mr. Vanselow will seek legal direction as to whether there is a need for the Board to revisit prior approved subdivisions. Mr. Record agreed with the Town Board that every day now is crucial for this project.

Mr. Vanselow moved to send a letter to the Town Board informing them of the Planning Boards' approval of the Land Use Plan. Mr. Donovan seconded the motion and a vote revealed all were in favor with Mr. Heidrich abstaining pending concerned citizen's ability to be heard. Motion carried.

Kinnarny Subdivision was tabled until February meeting at the request of the Attorney Mr. DeSantis. However Mr. DeSantis did do a preliminary presentation on a four-lot subdivision for Armstrong on Route 28 North Creek.

Subdivision Application #179-07 Front Street Development

A discussion with the Town Attorney, Mr. Jordan, revealed that the applicants are looking for preliminary approval on the whole project and final approval on phase I. There would also need to be Site Plan applications to cover the planned projects in Phase I. Mr. Heidrich presented a motion with a second by Bill

Donovan to accept application as complete. General discussion ensued on entry road location and golf course changes and what applicant is looking for. Mr. Record presented a motion to schedule a Public Hearing and with a second from Mr. Vanselow all were in favor no one opposed and no one abstained. Board to determine if applicants need individual site plans or a combined one. Mr. Vanselow advised that the definition of Site Plan is a single parcel and single applications would allow the applicant to advance if only one entity had an issue.
