Major initiatives Ms. Hogan would like to follow are water district repairs, progressing with the sewer, assisting the Highway Department with repairs from the October storm and the disposal of surplus equipment, planning to move the Highway garage, continuing conversations on moving the Transfer Station, looking at converting to a DPW model, beginning the process of a comprehensive reval, moving the Connector Trail and pursuing a 'Trail Town' designation, and discussing the inventory of Town properties and their uses.

Bob Nessle said that solar power objectives should be added to the Town's list of 2020 goals. He thinks that it's possible to get the Town off the grid. Ms. Hogan responded that new zoning has to be in place before that can happen.

Dan W. Hitchcock asked about highway hiring practices. Ms. Hogan responded that because he (Dan W. Hitchcock) has hired a lawyer and threatened the Town with a lawsuit, the Board is not allowed to talk to him.
