• Landlord Authorization Form for ADK Mountain Club for Ididaride July 26, 2020

This item was tabled because the application does not state who the vendor is.

• Ratify authorization for Cedarwood Engineering to engage Atlantic Testing Laboratories in the amount of \$22,902 to be reimbursed through EFC grant for water district repairs.

Cedarwood is the engineering firm working on the WIIA grant with the Town. Part of the work that had to be done in order for engineering to move forward was boring and testing for which Cedarwood engaged Atlantic Testing Laboratories. Ms. Hogan is asking the Board to ratify authorization for Cedarwood Engineering to engage Atlantic Testing Laboratories in the amount of \$22,902 to be reimbursed through EFC grant for water district repairs.

Old Business:

• Tannery Pond Center Landlord Authorization Form for Dance Party (previously signed for February date, changed to April 4) The dance event at Tannery Pond scheduled in February was not held due to a snowstorm. It is now scheduled for April 4th. Tannery Pond is asking for a Landlord Authorization to serve alcohol at the event. Ms. Hogan stated that the insurance company has expressed unease regarding this, as all other events serving alcohol have an outside vendor with a liquor permit serving.

There was discussion of pros and cons and measures taken by Tannery Pond to ensure the success and safety of the event. Ms. Hogan suggested going back to the insurance company to ask what other steps would be needed to have them be comfortable with the event.

Mr. Stevens restated his objection to serving alcohol on any Town property.

• Set public hearing for local law changing date for BAR

Because Johnsburg shares the services of Assessor with Minerva, there is a conflict on the day of Board of Assessment Review. In order to change the date for the Town of Johnsburg, a Local Law must be passed. Ms. Hogan proposes a public hearing to discuss this Local Law on March 24th, prior to the next Town Board meeting.

Ms. Hogan now has literature to distribute regarding the importance of a full census count. She stated that every one percent undercounted will cost Warren County \$20,000,000.00 over ten years. One percent is only 650 people. Ms. Arnheiter suggested a local mailing.

Committee Reports:

• Highway

Ms. Arnheiter/Mr. Arsenault met with the Highway Department and the contract (same as last year) was agreed upon. It was also agreed that a multi-year contract would be preferable in the future.

• Buildings, Parks and Rec.

Mr. Gonyo said he is waiting for the site plan for Riverfront Park.

Mr. Stevens asked about money allocated to flooring at the Senior Meal Site and doors both there and at Tannery Pond, wondering where these projects stand and if something can be done to speed them up. Ms. Hogan responded that getting quotes has been difficult. Shuffling responsibilities in the Parks Department by making Thresa Dunkley a project manager may help.

Solid Waste

Ms. Lorah said she has spoken to Tracy Frisch, who is acting as a coordinator for a county-wide composting effort. Ulster County already has this in place and has offered to work with and mentor Warren County. There will be a teleconference with Ulster County within the next couple of weeks.

Water

Mr. Stevens met with Candace Lomax and Charlie Rawson to discuss rate increases for the Water Department. The decision has to be made before April 1st, or the increase would not go into effect until October.

Mr. Stevens said that Charlie Rawson has three priorities for the Water Department. One is the tank replacement. Another is the booster station, and the third is in regard to well #6 and rerouting of water in order to reduce the number of places cut off from water in the instance when he needs to turn the water off.

• Planning and Zoning

Mr. Arsenault and Ms. Arnheiter met with a few people for a brain-storming session and spoke about solar power.

• Marketing and Economic Development

Ms. Arnheiter said the Town of Johnsburg Community Development Corp in conjunction with the Economic Development determined that on April 3rd there will be access to a facilitator, broadband providers, Elise Stefanic, Betty Little, and Dan Stec. The next Broadband Symposium will potentially be scheduled, then, for Friday, April 3rd at Tannery Pond. Ms. Arnheiter intends to invite Verizon, making it a Broadband and Cellular Symposium.

• Fire and EMS

The expansion of the North Creek Fire District will be on the next Town Board agenda.
