RESOLUTION #133-19

IN MEMORIAM -Vincent D. Nevins

WHEREAS, recognizing Vincent D. Nevins, departed this life on May 18, 2019, and

WHEREAS, Vincent D. Nevins had dutifully served the Town of Johnsburg Highway for 35 consecutive years from 1960 until 1995; during the winter of 1968-1969 he combined two pieces of equipment, not previously used together, making some of the local roads passable again during the winter months

WHEREAS, Vincent D. Nevins had served the United States Army, proudly serving his country in the Korean Conflict until his honorable discharge in 1955;

NOW, THEREFORE,

• Ratify Supervisor signature on agreement with ORDA for July 6th celebrations

The Town celebrated Independence Day July 6th, at which time ORDA provided a misting tower and a climbing wall in Ski Bowl Park. In order to have that happen, Supervisor Hogan had to sign a contract with ORDA.

• Approve contract with Liquid Engineering for tank inspection and repair.

The south water tank has a leak, and both north and south tanks are due for inspection. The Board previously authorized Liquid Engineering for inspection. Now the Town has a new contract to fix the leak and do the inspections. The report on the condition of the tanks will be put into the grant application to the State for Water District repairs.

Town Historian, Deana Wood, would like to attend the Association of Public Historians of NYS conference September 9 - 11.

• Ratify Supervisor signature on contract with Camoin Assoc.

The County has applied on behalf of Town of Johnsburg for a huge grant for Main Street paving, sidewalks, a bike lane and streetscaping. In order to make that happen, the Town had to do a cost-benefit analysis. The county paid for it, but the Town has to sign the contract.

RESOLUTION #137-19

Mr. Arsenault presented the following resolution and moved its passage with a second from Ms. Arnheiter to ratify Ms. Hogan signing a contract with Camoin Assoc. for a cost-benefit analysis required for a grant submitted by Warren County on behalf of the Town of Johnsburg. • Authorize Intermunicipal Agreement with Warren County for solid waste and recycling.

The Town goes together with other Towns and Warren County on a contract for waste and recycling disposal.

• Discussion of budget priorities for 2020 and beyond

In the discussion of budget priorities for 2020 and beyond, the suggestion was made to budget for reserve funds for buildings (especially Scout Hall), landscaping, sand mine reclamation and cemeteries.

• Hiring for swim program

There are 40 kids in the swim program, so there is a need for an additional swim instructor.

Assessor

The Board has been discussing changing the model of the Assessor's Office from 32-hour full-time Assessor to a part-time Assessor, part-time Clerk, and a data collector. The Assessor would be 20 hours, the Clerk 19 or 20 hours, and the data collector paid by the number of properties visited.
