Presentation on Municipal Financial Planning

Jeanine Caruso of Fiscal Advisors & Marketing, Inc. gave a power-point presentation on municipal financial planning, explaining the role of the financial advisor, the advisory process, and types of debt obligations. This served as an introduction to the bond issuing process which the Board will be considering.

Garnet Lake Dam discussion

Mr. Arsenault asked Matt Fuller to detail the Garnet Lake dam situation. Mr. Fuller explained that the Town has an easement over the dam in order to maintain the road, but the Town does not own the dam. Ms. Hogan offered to pursue grants to fund dam maintenance but said the Town will not fund directly.

# • Budget discussion - Move from Tentative to Preliminary and set public hearing for October 20, 2020

Ms. Hogan began the discussion by noting that, in consideration of this year's financial difficulties and the inclination to not exceed the tax cap, there were challenging decisions creating the budget. Elected officials have a pay freeze, staff have a temporary pay freeze, and the highway department employees will have a one percent raise. She then went over the budget line by line.

#### • Employee handbook and Code of Ethics

Work is proceeding on updating the Employee Handbook and the Code of Ethics, which is a Local Law, needs review. Ms. Hogan is asking the Board to support sending the Code of Ethics to a Labor Attorney.

#### Committee Reports

• Sewer update

Mr. Gonyo spoke about a meeting of the Sewer Committee with Wayne LaMothe concerning funding. One avenue is to work with Community Development Corp. (CDC), on funding from the Northern Borders Regional Commission (NBRC). This is a federal-state partnership that is administered locally by the Lake Champlain, Lake George Regional Planning Board (LCLGRPB), and could be a step closer to forming a Sewer District.

• Occupancy tax update and discussion

Ms. Hogan discussed Occ Tax being a volatile source of income and is proposing a change in the award process. Currently awards are made in anticipation of money to be received. She would like to change this to spending the money received the previous year. The Board agreed to this change.

Christian Holt had the following comment: NYS pays taxes for the 240 acres of lake in Thurman to both JCS and town of Thurman... the 80 acres of land in Johnsburg no one pays taxes on...by lake I mean the actual lake not lake frontage. Ms. Hogan acknowledged this situation, saying that the solution would be to negotiate with the state. Mr. Holt agreed that negotiating with the state is difficult but that he hopes the situation is pursued.
