Approval of Minutes November 16, 2021 meeting

RESOLUTION #216-21

Mr. Stevens presented the following resolution and moved its passage with a second from Mr. Arsenault to approve the minutes from the November 16, 2021 meeting. With 5 members voting in favor the resolution is declared carried. Ayes -5 (Hogan, Arsenault, Stevens, Arnheiter, Gonyo) Nays -0

New Business:

• Countryside Animal Contract

The advice from the Animal Control Officer is to not contract with Countryside Animal Hospital because of their upfront fee of \$250 just to have them available and because he has certified kennels which are used with no charge to the Town. The Board agreed and no contract was approved.

• ZEO

Ms. Hogan said this issue is not ready to be resolved and will be brought up in the future.

• Senior Transportation

The arrangement with Warren/Hamilton Community Action Committee for Senior transport has been trips twice per month.

RESOLUTION #217-21

Mr. Arsenault presented the following resolution and moved its passage with a second from Mr. Stevens to approve the continued agreement with Warren/Hamilton Community Action Committee for Senior transport as trips twice per month. • Garnet Lake Civic Association

Ann Bernat gave a presentation regarding the Garnet Lake Dam, explaining that it has been deemed insufficient for heavy rainfall and that the cost of replacement is roughly \$3,000,000. The Association has received an \$80,000 grant and \$15,000 from the Town of Johnsburg. They have begun a "Save the Lake" fundraising campaign that is currently at \$209,000. She

asked that the community offer support and said the fundraising campaign can be found at garnetlake.org.

Christian Holt asked if Thurman or New York State has offered any support. Ms. Hogan said that the DEC and NYS have been approached and that no – they will not help further than the grant.

Mr. Gonyo asked if there was a timeline for replacement and Ms. Bernat replied that it is not 'urgent'.

Mr. Stevens asked about a goal for fundraising, and Ms. Bernat said there is no hard target until the design is finalized.

• Prior Written Notice of Defects Law

The Town's insurance company has suggested having a Local Law to increase the Town's coverage for preventable accidents due to lack of proper maintenance. The Board is being asked to set a Public Hearing on creating this Local Law.

RESOLUTION #218-21

Mr. Stevens presented the following resolution and moved its passage with a second from Mr. Gonyo to set a Public Hearing on creating a Local Law for the purpose of increasing the Town's insurance coverage for preventable accidents due to lack of proper maintenance, called a Prior Written Notice of Defects Law, on January 4^{th} at 7:00 pm.
