## August 4,2015 - Case #11400219 - Re: SPEED LIMIT REQUEST PARK ROAD, TOWN OF JOHNSBURG WARREN COUNTY - Dear Mr.

Tennyson: This is in response to your September 29, 2014 letter to this office, requesting a speed limit reduction on Park Road in the Town of Johnsburg. We conducted a field investigation of Park Road between Route 8 and Garnet Lake

Road (CR 72). Based on our review, we have determined that a speed limit reduction is warranted for this highway. We have written a Notice of Order for a 40 mph speed limit on the requested section of Park Road. Upon receipt of this Order, which is being filed with the Secretary of State, you may arrange to have the appropriate speed limit signs installed in accordance with the MUTCD and NYS Supplement.

#### <u>August 4, 2015 - Case #1140024 - Mr. Jeffery E. Tennyson County</u> <u>Superintendent Warren County - Re: SPEED LIMIT REQUEST</u> HARRINGTON ROAD TOWN OF JOHNSBURG WARREN COUNTY -

Dear Mr. Tennyson: This is in response to your September 26, 2013 letter to this office, requesting a speed limit reduction on Harrington Road in the Town of Johnsburg. Upon inspection of this road, we found it to be a dirt/sand covered road. It is our practice not to establish regulatory speed limits on unpaved highways. Our reasoning is that these types of highways are low volume highways generally used mostly by residents who are familiar with the roads and their conditions. The physical characteristics on unpaved highways in themselves control operating speeds depending on the weather, season and amount of road maintenance, so that establishing an appropriate speed limit is difficult even under favorable conditions. Finally, enforcement would most likely be minimal due to the low traffic volume.

Date: 07-31-16 - from: Victor H Sasse, 26 Knotty Pine Lodge Road, North River, NY 12856 - The reason for this letter is to make you and the members of the Town Board aware of a highway situation which exists in the Hamlet of North River. The road I'm referring to is Thirteenth Lake road. As you know this road begins at the State Road 28 and winds its way up hill and west in a series of curves (some blind) some short straight sections, and some rises which hide traffic. For the most part it is a narrow road. Besides serving local residents, its traveled by campers, hikers, fisher persons, and hunters. Customers and employees going to and from Garnet Hill Lodge, and the employees of the Barton Mining Co. This industry hauls its products daily using tandem wheeled trucks to the Hudson river facility located in Hamilton County. In addition to these trucks, the Town of Johnsburg Highway Dept. and neighboring Highway Departments travel back and forth hauling tailings,

Barton's by product. this product is also hauled by tandem wheeled trucks, they are large and heavy. Without a doubt Thirteenth Lake road handles a considerable amount of traffic. What is a concern is the speed at which this traffic travels. There are signs which indicate curvy roads, black backed signs with orange numerals which state 30 mph. Note: at this point in this letter I would like to share some information with you regarding these aforementioned signs. Surprisingly these speed signs are only suggestions, and are not covered by law which to me seems ridiculous. Also that the speed signs are not set by law enforcement. To get a bona fide speed limit the town has to pass a resolution for the speed it wants posted. In my experience of having lived off, and traveled on 13th. Lake road for 43 years, I consider it a narrow road, having blind curves, travels through a residential area w/many driveways entering onto it, a church and a firehouse and eight road intersections. The excessive speed at which many persons presently travel this road is a serious accident waiting to happen. I and the residents of North River are requesting that the legal speed that motorists are allowed to travel on thirteenth Lake Road be posted at 30 mph. this road cannot be traveled safely in excess of that speed. this has been proven countless times in the area where the road has many curves. it is also a prudent speed to travel though a residential area. Life is too precious to be wasted because some misguided individuals have to drive fast. there are places where you can do that if you are so included, it's called NASCAR.

<u>August 17,2015 - Tim Record</u> - I would like to purchase the small building at the dump which the town received from Gore. I need it to store my kettle corn machine. I have experience with jacking of heavy railroad coaches and locomotives and will safely move the building with the assistance of neighbor, Matt Allen. The floor is gone. I would like to offer \$50 for the building. Thank you for your consideration in this matter.

Supervisor Vanselow asked the Board if they were in favor of him submitting a request to Warren County on behalf of Mr. Sasse to have 13th Lake Road posted at 30 mph.

Mr. Olesheski presented the following resolution, and moved its passage with a second from Mr. Stevens, giving Supervisor Vanselow permission to submit a request to Warren County on behalf of the Town Board to have 13th Lake Road posted at 30 mph.

With 4 members voting in favor, the resolution is declared carried. Ayes-4 (Stevens, Arsenault, Olesheski, Vanselow) Nays- 0

Supervisor Vanselow, regarding the letter from Mr. Record about the small shack at the transfer station in which Gore gave the Town at the time of the fire. There is no floor in it and it smells so it was never used and it is just taking up space. Mr. Olesheski asked if there was any Resolution in acceptance of the shack. Supervisor Vanselow stated he didn't believe so.

#### **OLD BUSINESS:**

<u>Upper Hudson Trail Association</u> - Supervisor Vanselow stated that he had received two different resolutions in support of the Upper Hudson Trail Association which are fill in the blanks and as soon as he has done so he will forward them on to the Board Members.

<u>Swimming Up-Date</u> - Supervisor Vanselow stated that we have received the OK from DOH to have the Beach open Friday to Sunday from Noon to 4PM and we have lined up a life guard.

Noise Ordinance Up-Date - Supervisor Vanselow first stated that he has Attorney Fuller drafting a noise ordinance, which would have to go to public hearing. Supervisor Vanselow then turned the floor over to Ms. Danae Tucker, who is the ZEO for the Town. Ms. Tucker thanked the board for letting her change her work schedule, and she went on to state that the construction companies really like the hours because that way they don't have to leave there job during the day they can meet with her after their workday. Ms. Tucker went on to state that she will be meeting with Attorney Fuller next week regarding the Edwards Hill problem. Ms. Tucker is hoping to have a determination within the next two weeks. Ms. Tucker proceeded with the next issue, Wevertown and the violation has returned. Ms. Tucker has spoken with the violator and also contacted her via a letter explain that she needs to remove the violators immediately. Ms. Tucker is going to be seeking advice from Attorney Fuller.

<u>ORDA CONTRACT</u> - Supervisor Vanselow stated that Mr. Pratt and he had a meeting and Mr. Pratt told him that they are planning to put up 4 Zip Lines at the Ski Bowl and possibly moving their summer activities to the Ski Bowl. They also, discussed the winter parking, plowing and the Summer Youth Program. Supervisor Vanselow explained that they will be meeting again regarding these issues.

<u>FLOWER GARDEN</u> - Supervisor Vanselow stated that an e-mail was received from Ms. Judy Brown requesting naming of the Ski Bowl Garden "Ski Bowl Perennial and Native Plant Gardens".
