The chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by section 10of the General Municipal Law. The Town of Johnsburg may invest the moneys in the Reserve Fund in the manner provided by section 11ofthe General Municipal Law, and consistent with the investment policy of the Town of Johnsburg. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner, which maintains the separate identity of the cash and investments of the Reserve Fund.

Except as otherwise provided by section 6-c [6-g] of the General Municipal Law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure

shall be made from this Reserve Fund without the approval of this governing board and without such additional actions or proceedings as may be required by section 6-c [6-g] of the General Municipal Law, including a permissive referendum if required by subdivision 4 of section 6-c [6-g].

WHEREAS: It is in the Town's best interest to correct said inventory, NOW THEREFORE BE IT RESOLVED THAT the following represents a true and accurate record of changes to the State inventory list:

- **Casterline Rd** add .06 miles, total length .32 miles, begins CR 78, ends –deadend
- **George Dunkley Rd** -add .04 miles, total length .13, begins Barney Hill Road, ends -dead end
- **Knotty Pine Rd** add .10 miles, total length .10 miles, begins CR 78, ends dead end
- **Liddle Rd-** add .12 miles, total length .12 miles, begins Dillion Hill Rd, ends dead end (Cul-de-Sac)
- **Millington Rd** -add .15 miles, total length .15 miles, begins -dead end, ends Vacar Rd
- Osborne St -add .10 miles, total length .10 miles, begins -CR 77, ends dead end
- **Smith Rd** -add .08 miles, total length .08 miles, begins -CR 78, ends dead end
- **Steele Rd-** add .07 miles, total length .07 miles, begins -dead end, ends SR 28

- **Stewart Rd-** add .08 miles, total length .33 miles, begins -dead end, ends Goodman Rd
- **Wilbur Hitchcock Rd-** add .15 miles, total length .15 miles, begins Edwards Hill Rd, ends -dead end
- **Vacar Rd** -add .32 miles, total length .32 miles, begins dead end, ends River Rd
- A. **Meade Rd** add .06 miles, total length .20 miles, begins dead end, ends Crane Mtn Rd
- **Bates Cemetery Rd** add .12 miles, total length .28 miles, begins NY 8, ends Goodman Rd
- **Big Shanty Rd** add.23 miles, total length .43 miles, begins tum around, ends dead end
- **Hanpeter Rd** add .16 miles, total length .16 miles, begins dead end, ends Harrington Rd

Furthermore the Town recognizes these roads are Town roads, the Town is responsible for them legally and for their maintenance and they are open to the travelling public without restriction.
