We, The Town Board of the Town of Johnsburg, publicly state that the people of the Johnsburg Central School District should not base their decision on reorganization on any communication which the Town Board may have had with the President of the Johnsburg Central School Board or the Supervising Principal of the Johnsburg Central School. All members voting favorable – resolution carried. (Above Motion seconded by Mr. Roblee)

RESOLUTION ESTABLISHING STANDARDS OF CONDUCT FOR OFFICERS AND EMPLOYEES OF THE TOWN OF JOHNSBURG (July 28, 1970)

Messrs. Cornwall and Roblee introduced Resolution No. 54 and moved its adoption: WHEREAS, Section 806 of the General Municipal Law, as amended by Chapter 1019 of the Laws of 1970, provides that each town shall enact a code of ethics setting forth for the guidance of its officers and employees the standards of conduct reasonably expected of them, be RESOLVED, that the Town of Johnsburg hereby adopts the following Code of Ethics to serve as a guide for official conduct of the officers and employees of the Town of Johnsburg

CODE OF ETHICS - TOWN OF JOHNSBURG -

Resolution Establishing Standards of Conduct for Officers and Employees of the Town of Johnsburg

<u>Section 1</u>. Pursuant to the provisions of Section eight hundred six of the General Municipal Law, the Town Board of the Town of Johnsburg recognizes that there are rules of ethical conduct for public officers and employees which must be observed if a high

degree of moral conduct is to be obtained and if public confidence is to be maintained in our unit of local government. It is the purpose of this resolution to promulgate these rules of ethical conduct for the officers and employees of the Town of Johnsburg. These rules shall serve as a guide for official conduct of the officer and employees of the Town of Johnsburg the rules of ethical conduct of this resolution as adopted, shall not conflict with, but shall be in addition to any prohibition of article eighteen of the General Municipal Law or any other general or special law relating to ethical conduct and interest in contracts of municipal officers and employees.

Section 2. Definition.

- (a) "Municipal Officer or Employee" means an officer or employee of the Town of Johnsburg, whether paid or unpaid, including member of any administrative board, commission or other agency thereof. No person shall be deemed to be a municipal officer or employee solely by reason of being a volunteer fireman or civil defense volunteer, except as chief engineer or assistant chief engineer.
- (b) "Interest" means a pecuniary or material benefit accruing to an officer or employee of the Town of Johnsburg including a pecuniary or material benefit accruing to the officer's or employee's (1) spouse, minor children and dependents; (2) a firm, partnership or association of which such officer or employee is a member.
- <u>Section 3. Standards of Conduct.</u> Every officer employee of the Town of Johnsburg shall be subject to and abide by the following standards of conduct:
- (a) Gifts. He shall not, directly or indirectly, solicit any gift; or accept or receive any gift having value of twenty-five dollars or more, whether in the form of money, services, loan, travel, entertainment, hospitality, thing or promise, or any other form, under circumstances in which it could reasonably be inferred that the gift was intended to influence him, or could reasonably be expected to influence him, in the performance of his official duties or was intended as a reward for any official action on his part.
- (b) Confidential information. He shall not disclose confidential information acquired by him in the course of his official duties or use such information to further his personal interest.
- (c) Representation before one's own agency. He shall not receive, or enter into any agreement, express or implied, for compensation for services to be rendered in relation to any matter before any municipal agency of which he is an officer, member or employee

or of any municipal agency over which he has jurisdiction or to which he has the power to appoint any member, officer or employee.

- (d) Representation before any agency for a contingent fee. He shall not receive, or enter into any agreement, express or implied for compensation for services to be rendered in relation to any matter before any agency of his municipality, whereby his compensation is to be dependent or contingent upon any action by such agency with respect to such matter, provided that this paragraph shall not prohibit the fixing at any time of fees based upon the reasonable value of the services rendered.
- (e) Disclosure of interest in legislation. To the extent that he knows thereof, a member of the Town Board and any officer or employee of the Town of Johnsburg whether paid or unpaid, who participates in the discussion or gives official opinion to the Town Board on any legislation before the Town Board shall publicly disclose on the official record the nature and extent of any direct or indirect financial or other private interest he has in such legislation.
- (f) Disclosure of interest in certain applications. A member of the Town Planning Board and any officer or employee of the Town of Johnsburg whether paid or unpaid, who participates in the discussion or gives official opinions to the Planning Board on any application for review before the Planning Board shall publicly disclose on the official record the nature and extent of any direct or indirect financial or other private interest he has in such application.
- (g) Disclosure of employment of relatives. No person who is related by blood or marriage to a public officer or department head of the Town of Johnsburg shall be employed by said public officer or department head before publicly disclosing the name, relationship and proposed employment to the Town Board and upon consent of a majority of said Board at a duly held meeting thereof.
- (h) Investments in conflict with official duties. He shall not invest or hold any investment directly or indirectly in any financial, business, commercial or other private transaction, which creates a conflict with his official duties.
- (i) Private employment. He shall not engage in, solicit, negotiate for or promise to accept private employment or render services for private interests when such employment or service creates conflict with or impairs the proper discharge of his official duties.
- (j) Future employment. He shall not, after the termination of service or employment with the Town of Johnsburg appear before any board or agency of the Town of Johnsburg in

relation to any case, proceeding or application in which he personally participated during the period of his service or employment or which was under his active consideration.

<u>Section 4</u>. Nothing herein shall be deemed to bar or prevent the timely filing by a present or former officer or employee of any claim, account, demand or suit against the Town of Johnsburg or any agency thereof on behalf of himself or any member of his family arising out of any personal injury or property damage or for any lawful benefit authorized or permitted by law.

<u>Section 5. Distribution of Code of Ethics</u>. The Supervisor of the Town of Johnsburg shall cause a copy of this Code of Ethics to be distributed to every officer and employee of the Town of Johnsburg within 30 days after the effective date of this resolution. Each officer and employee elected or appointed thereafter shall be furnished a copy before entering upon the duties of his office or employment.

<u>Section 6. Penalties.</u> In addition to any penalty contained in any other provision of law, any person who shall knowingly and intentionally violate any of the provisions of this Code may be fined, suspended or removed from office or employment, as the case may be, in the manner provided by Law.

<u>Section 7. Effective date</u>. This resolution shall take affect 20 days after it is filed in the office of the State Comptroller.

<u>Resolution #83 – December 22, 1970</u> - Resolution providing for the regulations of the Operation of Snowmobiles in the Town of Johnsburg, Warren County, NY

Resolution #83 – Introduced by Richard Cornwall – Justice of Peace, seconded by Lowell Nevins – Resolved that pursuant to the provisions of Article 8 of the Conservation Law, effective May 8, 1970, the Town Board of the Town of Johnsburg hereby adopts the following rules and regulations providing for the operation of snowmobiles in the Town of Johnsburg.

<u>SECTION 1: PURPOSE -</u> It is the intent of this resolution to promote the safe and proper use of snowmobiles in the Town of Johnsburg by encouraging their use and development and minimizing detrimental effects of such use upon the environment, and further to carry out the intent and proposed of Article 8 of the Conservation Law, effective May 8, 1970.

<u>SECTION 2: RULES, REGULATION, DEFINITIONS</u> – All of the provisions, definitions, rules, and regulations set forth in Article 8 of the Conservation Law are hereby adopted and made applicable to this resolution.

SECTION 3: OPERATION OF SNOWMOBILES ON STREETS AND HIGHWAYS – In addition to the permissible use of public highways specified in Section 8-0303 of Article 8 of the Conservation Law, snowmobiles may be operated on public streets and highways in the Town of Johnsburg in the following cases and no other:

- (A) <u>EMERGENCIES</u> In an emergency, as so declared by the Supervisor of the Town of Johnsburg, and for the purpose of emergency travel only, snowmobiles may be operated on any street or highway under the jurisdiction of the Town of Johnsburg, during the period of time when and at locations where snow upon the roadway renders travel by automobile impracticable.
- (B) <u>UNPLOWED HIGHWAYS</u> Snowmobiles may be operated on Town highways during the periods when and at locations where the highway is customarily unplowed and used during the winter months for automobile travel.
- (C) THE FOLLOWING TOWN ROADS ARE HEREBY DESIGNATED AS UNCONGESTED HIGHWAYS AND SNOWMOBILES MAY BE OPERATED ON THE SHOULDERS THEREOF AS HEREINAFTER SET FORTH:

- (1) Cornwall Road 1.6 miles
- (2) Beach Road .68 miles
- (3) Harvey Road 1.3 miles dirt only
- (4) 13th Lake Road 3rd bridge to 4H road
- (5) Cemetery Road .6 miles
- (6) River Road 5.5 miles from Duell Place to Millington Road
- (7) Millington Road .32 Miles
- (8) Vacar Road .32 miles
- (9) Austin Pond Road .75 miles
- (10) Holland Road .4 miles
- (11) Dillon Hill Road .45 miles
- (12) Heath Road -1.23 miles
- (13) Riverside Station Road 2.35 miles dirt portion only
- (14) Washer Hill Road .10 miles only a portion
- (15) Hudson Street Road .20 miles from Sawyers camp to bridge beyond C. Ross residence
- (16) Cleveland Road .40 miles
- (17) Crane Mtn Road 2.02 miles
- (18) Crosby Road .38 miles
- (19) Armstrong Road 2.12 miles
- (20) Bartman Road 2 miles from Heath Farm to State snowmobile parking lot
- (21) Coulter Road 2.49 miles
- (22) Thissell Road .97 miles
- (23) Barney Hill Road 1.3 miles
- (24) Oven Mtn Road 3.09 miles
- (25) Oven Mtn Extension .47 miles
- (26) Back Sodom Road 2.4 miles

- (D) <u>OUTSIDE SLOPES</u>: Snowmobiles may operate on the slopes or area outside the guard rail, if any, or on the back side of any snow embankment of any Town road in the Town of Johnsburg, providing the area outside the guard rail or snow embankment is on Town right of Way and not private property.
- <u>SECTION 4: ADDITIONAL RULES AND REGULATIONS</u> In addition to the Rules and Regulations provided in Article 8 of the Conservation Law for the use and operation of snowmobiles, the following rules shall apply in the Town of Johnsburg

- (A) <u>AGE OF OPERATOR</u> No person under the age of at least 10 years shall operate a snowmobile upon Public Lands, Waters, Property and Roads in the Town of Johnsburg.
- (B) <u>FINANCIAL RESPONSIBILITY</u> Every owner of a snowmobile used or operated on Public Lands, Waters, Property and Roads in the Town of Johnsburg. Evidence of financial responsibility as provided herein shall be presented to any law enforcement officer upon request.

<u>SECTION 5: EFFECTIVE DATE</u> – This resolution shall take effect immediately and on filing with the Department of Conservation.

And be it further resolved that The Town clerk of the Town of Johnsburg be directed to

- (1) Mail a certified copy of this resolution to the Department of Conservation
- (2) Post a copy of this resolution on the Town of Johnsburg Bulletin Board
- (3) Have a copy of this resolution published in 2 issues of the North Creek News.
