# Minutes of the Town of Johnsburg Organizational Meeting January 7, 2014 Held at the Wevertown Community Center, Wevertown, NY

Minutes of the regular meeting of the Town Board of the Town of Johnsburg held on Tuesday January 7, 2014 at 7:00PM at the Wevertown Community Center, Wevertown, NY.

Supervisor Vanselow called the meeting to order at 7 p.m. and the pledge to the flag was led by Supervisor Vanselow.

Roll call showed the following persons present: Supervisor Ronald Vanselow; Town Councilmen Eugene Arsenault, Katharine Nightingale, Peter Olesheski, Jr., Arnold Stevens; Town Clerk Jo A Smith.

Supervisor Vanselow announced that the oath of office for the newly re-elected Councilpersons Katharine Nightingale, Arnold Stevens; Supervisor Vanselow and newly elected Town Clerk Jo A Smith would be administered at this time; the Town Clerk administered the oath of office.

#### RESOLUTION #1-14

Mr. Arsenault presented the following resolution and moved its passage with a second from Ms. Nightingale to accept the minutes of the December 17, 2013 regular Town Board Meeting as written.

With 5 members voting in favor, the resolution is declared carried. Ayes-5 (Arsenault, Nightingale, Olesheski, Stevens, Vanselow) Nays- 0

Supervisor Vanselow asked about accepting the 284 agreement as submitted by Mr. Hitchcock Superintendent of Highways.

## RESOLUTION #2-14

Mr. Stevens presented the following resolution and moved its passage with a second from Mr. Olesheski to accept the 284 agreement that was submitted by Mr. Hitchcock Superintendent of Highways.

With 5 members voting in favor, the resolution is declared carried. Ayes-5 (Arsenault, Nightingale, Olesheski, Stevens, Vanselow) Nays - 0

Supervisor Vanselow regarding the Ski Bowl plowing issue, that we are bound by contract with an agreement with ORDA to plow snow at the Ski Bowl. Supervisor Vanselow stated that it is probable a Parks function, as Mr. Hitchcock stated, though they do not have the equipment to do it. Supervisor Vanselow has spoken with Mr. Mike Pratt in the past and Mr. Pratt stated that they would move the piles of snow if a loader was available but would not do the plowing. Supervisor Vanselow said that if they put it out to bid, that the bid process would take about a month and we are already so far into the season. Mr. Arsenault stated that they keep expanding the parking lots and plowing more than once in a snow storm is not feasible. Supervisor Vanselow explained that the employees have called the town hall and also called Mr. Hitchcock complaining that the parking lot is not plowed - Mr. Hitchcock's priorities is the Bus Routes and roads before parking lots. Ms. Cherie Ferguson states that they started with one parking lot and they are up to 3 full lots and the agreement was for 20 years which was signed in 2006. Supervisor Vanselow said he would talk with Mr. Mike Pratt again to see if something could be worked out.

Mr. Arsenault asked about the 12½% that Mr. Hitchcock was talking about. Supervisor Vanselow stated that FEMA pays 75% - State pays 12½% and the Town pays 12½%. This time the state is not paying 12½% and Bettie Little has been approached on this and she was not aware of the situation. She is looking into this. Supervisor Vanselow stated that is why Mr. Hitchcock is stating the town will be paying 25% instead of 12½%.

Supervisor Vanselow explained that this is the organizational meeting for the year of 2014 and that there were several annual resolutions and appointments which would be done at this time.

Mr. Olesheski presented the following resolution and moved its passage with a second from Ms. Nightingale to adopt the salaries of elected and appointed officials as per the final adopted budget for 2014.

Supervisor Vanselow suggested keeping the rate of reimbursement for mileage at the same level as year 2013 of \$.50 per mile.

Association of Towns when due during the year of 2014; Authorize the Town Clerk to publish, in two issues, a summary of the 2013 Annual Report of the Supervisor of the Town of Johnsburg.

#### PRIVILEGE OF THE FLOOR

Mr. Robert Nessle regarding the snow removal from the Ski Bowl Park, that we are in a contract with ORDA for the snow removal for the park, so we need to do it and find the funding for it.
Ms.

Ferguson suggested maybe taking money out of occupancy tax to do the removal of the snow at the Park. Mr. Olesheski stated that the committee is not in favor of using occupancy tax money for snow removal. Mr. Olesheski suggested having the town attorney to take a look at the contract. Mr. Nessle believes that the town just needs to support ORDA and plow the Parking lots at the Park. Mr. Arsenault just wants it to work out. (A long discussion)

Mr. Olesheski brought up the question of a Town Lawyer. Supervisor Vanselow stated that a couple of years ago the Board authorized to use Jordon & Kelly and other attorneys as needed.
