Letter from Mr. Crikelair dated 9/19/2016 - As we approach the important Fall and Winter seasons, we again expect many Tourists and Skiers to visit our uniquely Adirondack Hamlet Community and tour the surrounding area, particularly the Ski Bowl Park. In an effort to welcome folks with the hope that they enjoy and remember well their visit, and return regularly, we ask that the Town Board pass the following Resolution: "The Town Board directs the Highway Superintendent to take immediate action to clean up the yard in front of the Town Maintenance Garage by removing all culverts, snow plows, sanding equipment and the storage of old equipment."

Letter from Garnet Hill Lodge dated 9/8/2016 – RE: Garnet HillLodge -Notice to Municipality of Intent to File Transfer Application with NYS Liquor Authority - We are writing in connection with the Transfer Application to be filed with the New York State Liquor Authority to allow for a change in ownership of Garnet Hill Lodge. The application allows for a liquor license to be obtained by the new owner of the Lodge, Garnet Hill Resort Associates, Inc., a company wholly owned by James and Frances Rucker. The scope of the application for the liquor license is to remain consistent with the liquor license in place for the current owner, Pine Meadows Associates Inc., a company owned by Don Preuninger. Enclosed please find a copy of the Municipality Notice form that has already been provided to the Town. Because time is of the essence for filing this application before the transfer of ownership that is scheduled for September 30, 2016, ask that the Town of Johnsburg waive the 30-day notice period allowed by the Municipality Notice. If this meets with Town's approval, we ask that you kindly issue a written waiver of the 30-day notice.

Letter from The North Creek United Methodist Church – Philip Sangster – Chairman Administrative Council - Subject: Renting Wevertown Community Center - The North Creek United Methodist Church is interested in renting the Wevertown Community Center on a regular basis. The time would be every Sunday morning from 9:00 AM to 11:30 AM for our church service. We would only need the top floor for our service. We would have a maximum attendance of 30 people and would set up and take down the area. This would start in January of 2017 and continue at least one year. We would like to know if this is possible and what we will be charged on a weekly basis. Thank you for your consideration.

Supervisor Vanselow went on to state that he would like to do nothing regarding Mr. Crikelair's request. Mr. Olesheski stated that the Highway Superintendent had reached out to him today about Mr. Crikelair's request and Mr. Olesheski believes that the Town shouldn't have to deal with him anymore, it should all be through the attorney.

Mr. Stevens wants to see a survey map and to have someone go and show them where the boundaries are.

Supervisor Vanselow requested the boards thoughts and feelings on the North Creek United Methodist Church request. Mr. Olesheski asked if this was because of a financial problem and that he would like Mr. Sangster to come and speak to the board.

Ms. Nightingale presented the following resolution and moved its passage with a second from Mr. Arsenault RESOLUTION AUTHORIZING WAIVER OF 30 DAY NOTIFICATION REQUIRED BY NEW YORK STATE LIQUOR AUTHORITY IN CONNECTION WITH THE TRANSFER OF OWNERSHIP OF GARNET HILL LODGE

WHEREAS, Garnet Hill Resort Associates, Inc. located at 39 Garnet Hill Road, North River, New York is acquiring Garnet Hill Lodge (the Lodge) and has applied to the New York State Liquor Authority for a transfer of a retail liquor license for the Lodge as set forth in its September 8, 2016 letter to the Town Clerk presented at this meeting, and

WHEREAS, Garnet Hill Resort Associates, Inc. has requested that the Town of Johnsburg waive the 30-day notification required by the New York State Liquor Authority (NYS) in an effort to expedite the permit for a change in ownership of the licenses premises, and

WHEREAS, the Town Board wishes to authorize the Town Clerk to notify NYS that the Town Board has waived the 30-day notification period before Garnet Hill Resort Associates permit is issued,

NOW, THEREFORE, BE IT

RESOLVED, that the Johnsburg Town Board hereby authorizes and directs the Town Clerk to notify the New York State Liquor Authority that the Town waives the 30-day notification period before the permit for the Garnet Hill Lodge premises is issued to Garnet Hill Resort Associates, Inc. and that the Town Board has no objection to such change in owner of the licenses premises, and

BE IT FURTHER,

RESOLVED, that the Town Board further authorizes and directs the Town Supervisor, and/or Town Clerk to take any actions necessary to effectuate the terms of this Resolution.

TAP Information for Town Board RE: Route 28 pedestrian overpass from the park to Main Street - Sept. 20, 2016 – Ms. Kelly Nessle

Transportation Alternatives Program, funded by Federal Highway Department, administered by NYS DOT. TAP fund non-motorized 'transportation" plan, design, construction, infrastructure - Minimum request \$250K Maximum request \$5 Million - Funding is 80% Federal; 20% local match; reimbursement basis

<u>Process</u>: Submit a pre-application before September 30th to NYSDOT liaison; meet with this person soon after; this pre-app should have as much info as possible in it - Submit application by October 21 - No town board resolution needed until awarded funding - 18 months to bid, plan, and design - After 18 months, construction (no limit on construction time)

<u>Application</u> Scope of work - Purpose of work; objectives - Benefits: measurable outcomes; economic development; safety; connectivity; - Community Support-particularly Senator/Rep; Mr. Bartholomew- SEQR - Anticipated Budget requirements – ROW - Anticipated donations or in-kind support for match; we need to be as clear as we can where the money is going to come from - Future maintenance and operation plan

<u>How to apply:</u> Possible to hire a consultant for application, but they cannot then be in the bid process to do the design, plan, build later, if we are awarded the money - Be aware of ROWs needed; if possible include documents - APA letter of non-jurisdiction probable (JIF sent Monday) per Brian Ford -NYS DOT—call Mark Kennedy to get his approval of project - Acquire NYS DOT highway work permit - Include all letters of support (local, big-wigs) -Indicate match and where coming from (?)

<u>20% Match</u> - Depends on total cost of project: Range of 500-1,000,000 just to be safe - 20% would therefore range \$100K to 200K - Wayne LaMothe: money from LWRP projects can be used as match; he was encouraging - CHIPS money can be used (Dan would not be happy!)

<u>Should I proceed?</u> - Send in pre-app with as much info as I can get - Have a meeting with liaison re budget figures and fill out application - Report back Oct.18 with what we have; you make final decision whether the town

commits to project or not.

<u>Siting</u> - Need town board member and business alliance member to work with us in the next few days to determine what looks like the best location

The Boards consensus was to move forward.

BREAK THE TAX CAP

RESOLUTION #125-16

Mr. Arsenault presented the following resolution and moved its passage with a second from Ms. Nightingale to pass the following Local Law:

Local Law No 2 of the year 2016 - Town of Johnsburg, County of Warren

A local law to override the tax levy limit established in General Municipal Law 3-c

Be it enacted by the town board of the town of Johnsburg as follows:

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Johnsburg pursuant to General Municipal Law § 3-c, and to allow the Town of Johnsburg to adopt a budget for the fiscal year 2017 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3c, which expressly authorizes the town board to override the tax cap by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Johnsburg, County of Warren is hereby authorized to adopt a budget for the fiscal year 2017 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.
