As you will notice, under the column "Detrmn." which stands for Determination, some have letter designations "I", "D", "N", or "U", while others have nothing.

L = National Register Listed

I = Individually National Register Eligible

D = National Register Eligible Historic District

N = Not Eligible

U = Undetermined, meaning they don't have enough information to make a determination.

The ones that are blank weren't given a determination for any number of reasons - often these were older inventories with no specific reason for a determination, such as a highway project, which would directly affect a property.
