

**NOTICE OF ANNUAL ELECTION
NORTH CREEK FIRE DISTRICT**

Town of Johnsbury, Warren County, New York

NOTICE IS HEREBY GIVEN that the annual election of the qualified voters of the North Creek Fire District in the Town of Johnsbury, New York, will be held at the North Creek Volunteer Fire Co., Inc. Fire House, 134 Main Street, North Creek, New York, on December 14, 2021 between the hours of 6:00 o'clock P.M. and 9:00 o'clock P.M. for the purpose of:

- A. Electing one District Commissioner for a five (5) year term commencing January 1, 2022 and ending December 31, 2026; and
- B. Voting upon the following Proposition:

PROPOSITION

Shall the North Creek Fire District be authorized to establish a Capital Reserve Fund to be funded as provided in the District's annual budget and as otherwise allowed by law for the purpose of paying all or part of the costs of equipment acquisition?

ABSTRACT OF RESOLUTION _____

By Resolution adopted by the Fire District on September 21, 2021, the Board of Fire Commissioners authorized creation of a capital reserve fund for the purchase of equipment. If the Proposition is approved, the fund will be created and moneys budgeted for that purpose and any moneys that are not required by law to be paid into any other fund or account may be deposited into this capital reserve fund. If this Proposition is approved, any future expenditure from the Fund will be made subject to permissive referendum.

- C. Voting upon the following Proposition:

PROPOSITION

Shall the North Creek Fire District be authorized to establish a Capital Reserve Fund to be funded as provided in the District's annual budget and as otherwise allowed by law for the purpose of capital improvements?

ABSTRACT OF RESOLUTION _____

By Resolution adopted by the Fire District on September 21, 2021, the Board of Fire Commissioners authorized creation of a capital reserve fund for making capital improvements. If the Proposition is approved, the fund will be created and moneys budgeted for that purpose and any moneys that are not required by law to be paid into any other fund or account may be deposited into this capital reserve fund. If this Proposition is approved,

any future expenditure from the Fund will be made subject to permissive referendum.

Every elector of the Town of Johnsburg, Warren County, New York, who is a registered voter of the Town and who has resided in the North Creek Fire District for the 30 days immediately before the date of the annual election shall be qualified to vote. A complete copy of the Resolutions to establish the Capital Reserve Funds may be obtained from the District Secretary/Treasurer.
